

RESOLUTION NO. *881*

**A RESOLUTION ESTABLISHING FEES AND RATES FOR PERMITS, LICENSES AND SERVICES WITHIN THE CITY OF DE SOTO**

**WHEREAS**, upon the recommendation of the Municipal Court Staff, the Governing Body has determined it is necessary to raise Municipal Court costs to \$55.00; and

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF DE SOTO, KANSAS:**

**SECTION 1: FEES.**

**SECTION 3: Effective Date.** This Resolution shall become effective on July 15, 2010.


