Charles Lawhead, 31760 West 83rd Street, De Soto, KS, distributed a photo of a pile of rocks dumped near his property. It is a hazard to his grandchildren. He is concerned about liability. The Mayor and City Administrator agree with Mr. Lawhead's concern, it will be addressed.

4. New Business:

a. Consider Resolution #1083 Exceeding Revenue Neutral Tax Rate.

Mr. Mills gave an overview of the revenue neutral rate resolution. He recommended that the council approve the resolution.

Mayor Walker addressed the concerns raised earlier by Mr. Lightwine. He pointed out that, despite valuation rising about 30%, the City's mill rate has decreased by 30% over several years. The City, like everyone else, has pressures from inflationary costs. The City's total budget is raising by 4%, a fraction of the inflationary percentage. Councilmember Murdock also commented about economic development, it should not raise taxes but instead should decrease them. She also pointed out that almost every City project is coming in way over budget due to inflation pressures. Councilmember Daniels expounded on the revenue neutral rate; the City's budget does not increase to the same extent that valuations are increasing. He also commented about development pays for development, and then when those facilities come on the tax rolls, they will add tax revenue.

Marsha Sassaman, 8700 Lynne Road, De Soto, KS: Asked about recent sales tax renewal, and why is City still raising taxes? The Mayor tried to address her concerns. Councilmember Daniels also commented on the benefits of the sales tax.

c. Consider Bids for Ottawa Street Project.

Mr. Brungardt led on this item. On August 19th, the City received five bids for Ottawa Street Project. The bids were very tight showing they are competitive. The low bidder was McAnany Construction in the amount of \$1,987,654.32. CFS Engineering recommended that the council accept the low bid from McAnany Construction in an amount not to exceed \$1,987,654.

The Mayor asked Mr. Brungardt to share information about the grant money the City received, which Mr. Brungardt did. The Mayor agrees bids are not going to get better. Council person Murdock commented that this project is an example of how the City is seeing costs going up, not going to get cheaper.

Motion by Councilmember Honomichl to accept the low bid from McAnany Construction in an amount not to exceed \$1,987,654, a \$100,000 contingency in the CIP, and authorize the Mayor to sign the contract; Second by Councilmember Lane.

Councilmember Honomichl commented about a conference he recently attended where this exact topic was discussed. Everyone is facing this same issue. Retention is key, and you do that by retaining employees you have by using bonuses.

Councilmember Ritter supports the approach. He asked a question about the recent MARC study, have we looked at that. City Administrator responded.

Councilmember Lane commented about some of the cities he looked at, he supports the City Administrator's concern and plan to address it.
