### **ORDINANCE NO. 2518**

#### **AN ORDINANCE TO ADOPT THE 2021 EDITION OF THE UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES.**

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF DE SOTO, KANSAS:

SECTION 1: Section 11-101 of Article 1 of Chapter XI of the De Soto City Code is hereby amended to read as follows:

INCORPORATING UNIFORM PUBLIC OFFENSE CODE. There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of De Soto, Kansas, that certain code known as the “Uniform Public Offense Code,” Edition of 2021, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are modified or changed previously by existing City Code Section 11-102 of Article 1 of Chapter XI, and Sections 11-201 through 11-209 of Article 2 of Chapter XI of the De Soto City Code. A copy of said Uniform Public Offense Code shall be marked or stamped “Official Copy as Incorporated by the Code of the City of De Soto, Kansas,” with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this section and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

SECTION 2: Repeal. Existing Code Section 11-101 of Article 1 of Chapter XI, and Ordinance No. 2496, are hereby repealed.

SECTION 3: Effective Date. This Ordinance shall take effect and be in full force from and after its passage, approval and publication as provided by law.
